Final Editorial

It is with mixed feelings that I write the final editorial for the *Enterprise Development and Microfinance* (EDM) journal, which published its final issue in December 2022. Launched in 1989, the journal was a collaboration between the Committee of Donor Agencies for Small Enterprise Development (DCED) and Intermediate Technology Development Group Publications (now Practical Action Publishing). The EDM journal offered 33 years of continuous publications, typically one issue per quarter.

As noted by William Steel in his article in the December 2009 issue, 'The initial attention to small enterprise development for its own sake has yielded to broader policy and strategic concerns with enhancing the contributions of enterprises of various sizes to "pro-poor growth" – the emerging shorthand for the dual objectives of economic growth and poverty reduction'. This remained the main focus of the journal over the years, with microfinance being a primary topic for many authors and readers.

I would like to take a moment to reflect on a few of the many accomplishments of the EDM journal. First, the journal filled a critical niche area – enterprise development and poverty reduction – and allowed authors to share experiences, contribute evidence, and participate in building an important body of knowledge that continues to exist in the Practical Action Publishing archives.

Second, the journal encouraged voices from practitioners and researchers, intentionally positioning itself at the nexus of development practice and academia. This was not always an easy space for the journal to inhabit, with tussles around the desire for more academic rigour and ranking versus greater sharing of hands-on experiences and concrete solutions to development challenges.

Third, contributions from northern and southern authors were encouraged, and there was no fee for publication, which further allowed the journal to remain open to a broad range of submissions. This enriched the contents of the journal in many ways. Recently, the journal took the next step to open-source publishing so that a wider audience could benefit from its valuable contents.

Finally, the EDM journal did not become stagnant. In the Steel article referenced above, the author traced how the contents of the journal shifted to meet the interests of the day. For example, enterprise development has been largely absorbed into value chain and market systems approaches, gender equality has become an important cross-cutting theme, and finance has evolved to include bank finance and impact investing.

I am sure our many authors, reviewers, and readers will have their own thoughts on key accomplishments of the journal, including many that I have not referenced here.

I would like to close by saying thank you to the editors, guest editors, authors, reviewers, advisory board, and executive committee members, along with the
